# **COMMUNITY INFRASTRUCTURE LEVY**

### 1. Purpose of the Report

- 1.1 To **inform** members of the funds available from the Community Infrastructure Levy collected on building developments within the parish.
- 1.2 To **approve** the transfer of monies to Abingdon Town Council from the collecting authority, VOWH District Council.

#### 2. **Summary**

- 2.1 To date, the Council has received £168,565 on CIL monies which is in relation to 14 building schemes within the parish. It is expected that the Council will receive a further £145,316 in 2021-22, and to date £138,368 will be due in 2022-23.
- The largest schemes included in the figures are the development on land North-West of Dunmore Road, which is due to result in CIL monies totalling £346,000, the development of the Bellinger's garage site (£43,417 received) and 55–59 Stert Street (£31,104 received).
- 2.3 The Council receives the 15% share of CIL collected (by the District Council) every six months. The Council is required to inform the District Council if they wish to continue receiving the funds or whether the Council would prefer for the District Council to retain until a suitable project to spend it on is agreed.

#### 3. Action required

- 3.1 The Council is requested to **note** the current and projected balances
- 3.2 The Council is requested to **approve** that CIL monies continue to be paid over to the Council at 6-monthly intervals.

The District Council Officers confirmed that the Town Council would not benefit from doing so, and so Members agreed to receive the monies every six months. Your officers recommend this arrangement continues.
