Remove and dig out low level shrubbery where possible or cut at ground level

Hand pull weeds and spray weed treatment on perimeter

Rake back and clean all veg 1m from perimeter

Dig down 1m wide 40-50mm deep and remove spoil on perimeter and infill with top soil and grass seed.

Definitions:

The Company - Oxford Direct Services Trading Limited

The Client - The company/organisation which requested the Company to provide a quote for undertaking the works/services specified in this document

The Services - The works/services specified in this document in regard to which the Client requested the Company to provide a quote

The Quote - The quote provided by the Company to the Client for providing the Services as specified in this document

The Fee - The sum specified in the Quote

- **1.** In the event that the Client appoints the Company to provide the Services, then subject to the terms of this Agreement, the Company hereby agrees to provide the Services to the Client.
- **2.** In consideration of its receipt of the Services, the Client shall pay to the Company (subject to Clauses 3 and 4 below) the Fee specified in the Quote.
- **3.** Unless the Company notifies the Client to the contrary, the Client shall pay the Fee to the Company within 28 days of receipt of the Company's invoice.
- **4.** The Quote provided to the Client will be valid for 30 days from the date on which it is supplied. Thereafter, the Company reserves the right to supply a revised Quote for its provision of the Services.
- **5.** The Company reserves the right to charge interest on any unpaid Fee which is due and owing at the rate of 8% above Barclays Bank base rate (applicable from time to time).
- **6.** The Company shall use all reasonable endeavours to provide the Services in a good and workmanlike manner, in accordance with the Client's instructions and within any agreed time frame, but in the event that any defect or failure in the supply of the Services is notified to the Company, the Company's sole liability (subject to Clauses 7 and 8 below) shall be limited to properly making good any such defect or failure.
- 7. In the event that the Client is of the view that any defect or failure has occurred in the Company's supply of the Services it shall notify the Company of its concerns in writing within 21 days of the date it becomes aware of such defect or failure.
- **8.** The Company does not seek to, and does not, limit its liability for any loss or damage which results from any death or personal injury caused by the Company's or its employees' negligence in providing the Services.
- **9.** The Client hereby confirms that it has supplied to the Company all relevant details and information required to enable the Company to accurately provide the Quote and to properly carry out the Services within the agreed time frame, and that it is aware of no circumstances or events which might prevent or prejudice the proper completion of the Services.
- **10.** The Client hereby confirms that it holds all the requisite authority to instruct the Company to carry out the Services, and warrants that in undertaking and providing the Services the Company shall not be infringing any third party rights.
- 11. The Client shall be required to issue a Purchase Order before any Service provision can commence.
- **12.** In the event that the Client is in breach of any of the terms set out herein, the Company may, without prejudice to any other rights it may then hold, terminate this Agreement with immediate effect. In such event the Client agrees to pay to the Company such part of the Fee as represents the work carried out up to the date of termination and any additional costs already incurred by the Company in regard to completing the Services.
