- Written submissions should be no longer than one side of an A4 sheet of paper.

#### **Replies to Objections to Proposals:**

Each response to a consultation will have been reviewed and appraised by County Council Officers and will be included in the report that will be presented to the Cabinet Member for Transport Management. However, it may be that you will not have received a reply to your response. Any responses that were <u>unable</u> to be included within the report will have been appraised by Officers and will be presented verbally during the meeting if necessary.
