Dialogue Society Oxford is Charitable Incorporated Organisation (CIO) (Charity No: 1212526), continuing its mission to promote interfaith understanding, intercultural dialogue, community engagement, youth development, and Equality, Diversity, and Inclusion (EDI) across Oxfordshire. Through educational programs, community projects, and dialogue initiatives, we aim to foster respect, cooperation, and social cohesion across diverse communities.

Life of a Chickpea: Abingdon Schools

Life of a Chickpea is an award-winning seminar series, recognised by the High Sheriff of Oxfordshire and BBC Oxford, that will promote British values and foster Equality, Diversity, and Inclusion (EDI) among students. Through storytelling, presentations, worksheets, Q&A sessions, and providing **Noah's Pudding (Dessert)**, students in **2 secondary schools and 5 primary schools in Abingdon** will explore democracy, the rule of law, individual liberty, and mutual respect for different faiths and beliefs.

Using the chickpea—a staple in many global cuisines—students will engage with shared human experiences, celebrating cultural diversity while reflecting on inclusion, social cohesion, and community understanding. Sessions will be delivered by local faith and community volunteers, including storytellers and representatives who will bring diverse perspectives into the classroom.

Funding will enable us to run **10 sessions in total** across these targeted schools, helping students, teachers, parents, and the wider community develop a stronger understanding of EDI and British values, contributing to a more inclusive and cohesive society.

The total cost of the *Life of a Chickpea* project is £10,000. This includes £3,500 for Noah’s Pudding, providing one for each of the 10 sessions at £350 per session. £1,260 will cover materials and worksheets for students, supporting interactive learning and exercises in each session. £1,500 is allocated for storyteller fees, with £150 per session to bring diverse perspectives and facilitate discussions. £1,250 is allocated for volunteer expenses, covering travel, refreshments, and any necessary training to enable volunteers to effectively support sessions. Finally, £2,490 is for the project coordinator, calculated at £15 per hour for 166 hours over 12 months, covering planning, scheduling, liaising with schools and community partners, overseeing volunteers, and ensuring smooth delivery of all 10 sessions.
