The proposals – which have been put forward following a review after complaints from residents about the lack of available parking for permit holders – seek to help protect the parking amenity that runs through the area, and to help provide equitable provision of permit holder parking for residents in the immediate vicinity. - The next piece of work will be to install the toucan crossing and bus stop on Twelve Acre Drive.

Lodge Hill works

- These roadworks are progressing on time.
- The works are due to move to the south slip.
